The Sovereign basis of Natural Law Court's

Where does our authority come from? That challenge confronts anyone who claim standing in Natural Law and its courts. But in truth, no such court can Lawfully operate without a legitimating power behind it: namely, a Constitutional Assembly of people that authorizes Natural Law Courts. Those Assemblies may be local, national and without limits, but must establish a Sovereign jurisdiction within which the court can operate, founded in the Natural Law without any other authorization.

One historic example told of such an Assembly and its work is in England January 4, 1649, known as the Commons or Parliament, created the "High Court of Justice" that Lawfully deposed and executed King Charles I, as a tyrant and war criminal. For ultimately all legal power derives from a Constitution established by free men and women gathered as equal Sovereigns in the Natural



Law. If our court do not have such a sanction they are merely a private weapon in the hands of a few, and thereby they mimic the autocracy of de-facto rules.

Another example is in Scandinavia December 4th 2022, where Natural Law Court of Justice proclaimed acknowledgement of the referendum, de-jure, in the regions of Donetsk, Lughansk, Zaporozje, Kherson, as claimed true fact where all in Creation is invited to participate.

From such a mandate do we sit today as a High Court and Jury, as an expression of the free will of the Commons in Parliament"*.
