"By the Roman law, every human being who had rights (other than such as were merely personal), or was subject to obligations or duties (other than such as were merely personal), had two personalities (personas), one natural, the other legal, artificial and fictitious; and it was in the latter that his rights were vested and upon the latter that his obligation and duties were imposed.

It was a peculiarity of the legal personality that, being the creature of law, it continued to exist so long as there was any reason for its existence.

It was not affected, therefor, by the death of the natural person, but continued its existence in the natural person's successor or heir".

artificial person *An entity, such as a corporation, created by law and given certain rights and duties of a human being: a being, real or imaginary, who for the purpose of legal reasoning is treated more or less as a human being.*

- *An entity is a person for purposes of the Due Process and Equal Protection Clauses but is not a citizen in Article IV § 2 and in the Fourteenth Amendment.*

This text above from the Black Law Dictionary, is an entrance to the fictitious corporate world based on legal terms and fantasies to which we unknowingly and unconsciously, through our passive, naive and deceptive state, consent to.

This legal fictitious persona, the corporation that was created, sometimes reffer to as "Straw-man" is a dead entity which the government want you to consent to be. - *Canon-2036 :A Cestui que vie trust, also known as a "fide commissary trust" is a fictional concept being a temporary testamentary trust, first created during the reign of Henry VIII of England through the Cestui que vie act of 1540 and updated by Charlse II through the Cestui que vie act of 1666 [after London burned and new City of London established] wherein an estate may be effected for the benefit of a person presumed lost or abandoned at "sea" and therefore assumed "dead" after seven years. Additional presumptions by which such trust may be formed were added in later statutes to include bunkrupts, minors, incompetents, mortgages and private companies.*

Here it clearly states that you seven years after your birth-event will be declared as dead, lost at sea (maritime admiral law). And make no mistake,, it still the fictitious persona it reffer to. Other countries have slightly different systems such as giving the child-birth-event a "person-number". All those ID-numbers, Birth certificates etc., serve only the slave system.
